APPLICATION:

ON NEW WOOD: apply a light coat by brush, spray, roll or wipe on the sanded bare wood (using 180 grit sandpaper). Then, after a few minutes wipe with a dry cloth to **ensure even absorption**. Take care not to apply a too heavy coat. Wait one (1) day before applying a second coat. Then after another day apply third coat.

ON PREVIOUSLY COATED WOOD: before applying the product, remove the old coating by sanding with a 180 grit sandpaper. Then, proceed as with new wood.

ATTENTION: cloths soaked with GX4741-10% Natura Parquet may be subject to spontaneous combustion. It is highly recommended that the cloths be soaked in water before being disposed of.

Special Notes *Do not use on rainy days or too hot weather. *Ensure timber is clean and dry prior to application.
